1. Program Overview

These Terms and Conditions govern the Refer & Grow Together referral program ("the Program") conducted by Integrated Business Technologies Pty Ltd ("IBT", "we", "us" or "our"). By participating in the Program, you agree to be bound by these Terms and Conditions.

2. Eligibility to Participate

The Program is open to individuals aged 18 years or older who are:

4. Reward Structure

4.1 Qualified Referral Reward

Upon successful qualification of the referral (i.e. once the Referee meets the criteria outlined in Section 3), the Referrer will be eligible to receive a **\$100 digital gift card** or have a donation of equal value made to a registered charity of their choosing.

4.2 Reward for Closed Opportunity

If the Referee enters into a signed engagement with IBT for any paid service or product offering within 6 months of the referral date, the Referrer will be eligible to receive a **\$500 digital gift card** or have a donation of equal value made to a registered charity of their choosing.

5. Reward Fulfilment

Rewards will be issued within 30 days of:

- Qualification of the referral (Stage 1); or
- Execution of a signed contract by the Referee and full receipt of initial payment (Stage 2).

Rewards will be delivered via email or other digital method. IBT reserves the right to substitute rewards of equal or greater value if necessary.
